Regulations and requirements

- No frozen deer.
- Deer must be skinned and quartered and in a closed, well iced, non-leaking cooler.
- Deer must be picked up as soon as possible after notification. (48 Hours after notification)
- Be aware that we will try to get you everything you want but the amount is dependent on the size and condition of your deer. We cannot fully process parts that have buckshot or broken bone fragments.
- Processing is first in, first out. Deer are processed one at a time. We do not mix your deer, what comes in is the same that goes out. We can not freeze your deer please make arrangements to have them picked up within 48 hours of processing.
